Narcotics Control Bureau intends to hire retired police officers (Sub Inspectors/ Inspectors) from Central Police Organisation(s)/ State Police as **Consultant** in NCB for pairvi work in trial courts as per the below mentioned terms & conditions laid down in Ministry of Finance (Deptt. Of Expenditure) OM No. 3-25/2020-EIIIA dated 09/12/2020.

Eligible retired officers, having good health and willing to work as Pairvi Officer in NCB on contractual basis may submit their applications to the concerned Zonal Directors, Narcotics Control Bureau (as per Annexure-II) on or before **15.06.2026** along with a self-attested copy of PPO, LPC/last salary slip and APARs of last 05 years.

**TERMS & CONDITIONS**

**1. Job Description:**

<b>Requirement</b>	<b>Eligibility Criteria</b>	<b>Work Experience/Job Profile</b>
Consultant for the work of a Pairvi Officer in Courts	Retired police officers / officials (SI / Inspectors) of the Central Police Organization / State Police	Minimum 03 years' experience in investigation or prosecution or court duty during trial of criminal cases.

**2. General Terms**

- 2.1 The candidate should have retired from Central / State Government and should have experience in investigation or prosecution of criminal cases or court duty in a criminal court of law.
- 2.2 The candidate should not have completed more than 4 years after his/her retirement from Government Service.

### 3. Nature of duties:

To assist the law officers and Investigating Officers in effective conduct of trial proceedings before courts. The officer shall coordinate production of witnesses, documents, case property and material objects, ensure timely service and follow-up of court processes, obtain copies of court orders and depositions, and maintain close liaison with prosecution, investigating teams and court staff. The Pairvi Officer shall also monitor progress of assigned cases, submit periodic status reports to the Zonal Director, immediately report any significant judicial developments, and undertake all ancillary tasks necessary for smooth, timely and effective prosecution of NCB cases.

### 4. Period of engagement:

- 4.1 The term of appointment shall be for an initial period of one (01) year which is extendable by another one year on the basis of performance, provided that the age of the Consultant should not exceed 65 years during the contract period.
- 4.2 The engagement of consultant would be on a full-time basis and he would not be permitted to take up any other assignment during the period of consultancy.
- 4.3 The engagement of consultant would be of a temporary nature against the tasks assigned. The engagement can be cancelled at any time by the Zonal Director NCB without assigning any reason.

### 5. Remuneration payable to consultants:

- 5.1 In case of Central / State Government retirees covered under the CCS (Pension) Rules, a fixed monthly amount shall be admissible, which shall be arrived at by deducting the basic pension (without commutation, if any) from the pay drawn at the time of retirement (i.e. Basic Pay + Dearness allowance admissible at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the Contract.
- 5.2 While fixing remuneration in case of Central / State Government retirees covered under the National Pension System (NPS), an amount equivalent to 30% of the **last basic pay** as drawn at the time of retirement shall be deducted from the last basic pay and the resultant amount shall be fixed monthly amount as remuneration (DoE (MoF) OM dated 18.10.2023).
- 5.3 No increment shall be allowed during the term of the contract.

- 6. Other entitlements of Consultants:**
- 6.1 Leave:**  
Paid leave of absence shall be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year shall not be allowed.
- 6.2 Tax Deduction at Source (TDS):**  
TDS/applicable taxes as admissible shall be deducted from the monthly remuneration. A TDS certificate shall be issued by the concerned DDO on demand.
- 6.3 TA/ DA:**  
No TA/DA shall be admissible for joining the assignment or on its completion. However, the consultant would be entitled to draw TA/DA on official tour, if any, as per his/her last entitlement at the time of retirement as per the Government norms.
- 6.4 Accommodation / HRA:**  
No accommodation / HRA shall be admissible.
- 6.5 Transportation Allowance:**  
An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment.
- 7. Working facilities to be provided:**  
Basic working facilities required for completion of task will be provided as per practices.
- 8. Confidentiality of data and documents:**  
The Consultant shall not utilize or publish or disclose or part to third party any data or statistics or proceedings or information gathered during the course of this assignment without the written consent of Zonal Director, NCB. The consultant shall sign an undertaking of confidentiality with the NCB.
- 9. Working Hours:**  
The consultant shall have to work as per the working hours of the NCB. However, depending on the exigency of work, one may be required to work beyond office hour or on holidays, but no extra remuneration or fee would be payable.

**10. Rights of NCB:**

Selection is strictly based on the availability of vacancies in NCB Zones only. Zonal Director, NCB reserves the right to cancel and not to proceed in the matter for engagement of consultant at any stage without giving any reason, whatsoever.

**11. Termination of Engagement:**

11.1 Zonal Director, NCB may terminate the services of the Consultant, if;

- a) The consultant is unable to accomplish the assigned works
- b) Quality of accomplished work is not to the satisfaction of NCB
- c) The consultant fails in timely achievement of the milestones as decided by NCB.
- d) The Consultant is found lacking in honesty and integrity.
- e) A regular Government official is posted in the vacancy post against which the consultant has been engaged.
- f) The requirement of consultant for the work assigned ceases to exist.
- g) The undertaking given by the candidate is found false.

11.2 The engagement contract can be terminated by giving 15 days' notice in writing from either side. The termination will be without prejudice to either party's rights accrued before termination.

12. Willing retired police officers (SI/Inspector) can apply for above engagement to the NCB Zonal office of their interest. The application form may be downloaded from the NCB website [[www.narcoticsindia.nic.in](http://www.narcoticsindia.nic.in)]. The duly completed application along with requisite documents as mentioned in the application form may be sent by post / e-mail to the Zonal Director concerned so as to reach on or before **15<sup>th</sup> June 2026**.
